Stronger Together Priorities and how they are applicable:

Support our residents to fulfil their potential

To support the strategic objective of supporting our schools to deliver a step change in educational attainment so that every young person has access to a school rated 'good' or better.

1.0 Reason and Purpose of Report:

1.1 This report provides Schools' Forum with a line by line breakdown of the central school services block (CSSB), for 2019-20, and seeks approval for the amounts on each line.

2.0 Recommendation(s):

2.1 That Schools' Forum approves the amounts on each line within the CSSB for 2019-20 totalling £5.409m.

3.0 Summary of Main Points:

- 3.1 The CSSB was introduced in 2018-19 to fund local authorities for the statutory duties they hold for both maintained schools and academies. The CSSB brings together:
 - Funding previously allocated through the retained duties element of the Education Services Grant (ESG).
 - Funding for ongoing central functions, such as admissions, previously top-sliced from the schools block.
 - Residual funding for historic commitments, previously top-sliced from the schools block.
- In 2019-20, ongoing responsibilities have been funded in broadly the same way as previously with updated baselines in line with the 2018-19 Dedicated Schools Grant (DSG) allocations. Funding for 2019-18 is £1,273,291(Pupil head count of 35,989 x £35.38 unit of funding).
- 3.3 Funding for historic commitments has been allocated at the same level as in 2018-19 which

	is £4,135,384. The Department of Education's (DfE) expectation remains that expenditure from DSG will reduce over time as contracts and other commitments reach their end points and they will continue to monitor this expenditure year-on-year. The DfE will seek explanations of expenditure recorded on section 251 returns where this is not reducing as
	expected.
3.4	From 2020-21, the DfE expect to start to reduce the historic commitments element of the CSSB where local authorities' expenditure has not reduced.
3.5	Where local authorities hold duties in relation to all schools (as set out in schedule 2 part 1 to 5 of The School and Early Years Finance (England) (No. 2) Regulations 2018 all schools must be treated on an equivalent basis.
3.6	As in previous years' Schools' Forum approval is required to confirm the amounts on each line.
3.7	Any movement of funding from the CSSB to the schools block or any other block is not subject to any limit and can be made in consultation with the Schools' Forum.
3.8	Table 1 below provides a line by line breakdown of the local authority CSSB allocations for 2019-20 and for comparative purposes the approved 2018-19 values.

As this commitment has now finished there is a risk of clawback by the DfE.

- Internal audit and other tasks related to the authority's chief finance officer's responsibilities under Section 151 of LGA 1972 except duties specifically related to maintained schools (Sch 2, 15e)
- Consultation costs relating to non-staffing issues (Sch 2, 19)
- Plans involving collaboration with other LA services or public or voluntary bodies (Sch 2, 15f)
- Standing Advisory Committees for Religious Education (SACREs) (Sch 2, 17)
- Provision of information to or at the request of the Crown other than relating specifically to maintained schools (Sch 2, 21)
