Fee calculation guidance from 1 April 2017

Calculating the correct search fee inclusive of VAT will mean that you need to exclude the LLC1 fee (exc. the admin fee) during the calculation.

Example 1

Residential LLC1 + CON29 (full search) fee of £95.32 inc. vat will need calculating as follows:

£25.00 non-vatable part of the residential LLC1 + Vatable elements (Admin fee inc. vat £23.04 + £47.28 (Cost of all CON29 questions as itemised below inc. vat)

Total fee inc. vat = £95.32

Example 2

Residential LLC1 + CON29 question 1.1j-l + optional question 22 + vat will need calculating as follows: £25.00 non-vatable part of LLC1 fee + Vatable elements (Admin fee inc. vat £23.04 + question 1.1j-l inc. vat £1.75 + question 22 inc. vat £1.54 Total fee inc. vat = £51.33)

Definition of residential:

All domestic properties or plots which do not contain a business premises

Definition of commercial:

Large areas of land/plots, business premises (inclusive of those which contain a residential property/flat) and any other type of land or property not defined as residential.

**Definition of an additional parcel:

Additional parcel means land (including a building or part of a building) which is separately occupied or separately rated or, if not occupied or rated, in separate ownership. E.g. a block of flats or several industrial/commercial units.

Where a residential property has been subdivided into separate flats and share a common boundary the local land charges team will judge the workload involved to determine whether an additional parcel fee applies. We advise you contact the Land Charges team prior to submitting your request to prevent any delays.

A separate search request should be made if the additional parcels don't contain a common boundary.
