

PROPOSED ORDER

THE CITY OF STOKE-ON-TRENT VARIED PUBLIC SPACE PROTECTION ORDER – CITY WIDE (No.1) 2020

Sections 59, 60, 61, 64 and 72 Anti-Social Behaviour, Crime and Policing Act 2014

Stoke-on-Trent City Council (“the Council”) in the exercise of its powers under Sections 60 and 61 of the Anti-Social Behaviour, Crime and Policing Act 2014, on being satisfied that the conditions set out in Section 59, 64 and 72 of the Act have been met, makes the following Order:

1. This Order may be cited as The City of Stoke-on-Trent Varied Public Space Protection Order (No.1) 2020 and shall come into operation on xxxx and shall have effect for a period of three years unless extended or discharged by further orders.
2. This Order varies the Public Space Protection Orders that transitioned from Gating Orders on the 20th October 2017 by operation of Section 75 of the Act.
3. This Order relates to the public right of way(s) over highway(s) described and listed in Schedule 1 to this Order and shown edged red on the map attached at appendix 1 (hereinafter referred to as the “Affected Highways”).
4. The Affected Highways being land in the area of the Council and is land to which the Anti-Social Behaviour, Crime and Policing Act 2014 (“the Act”) applies and will be protected by this Order.
5. The effect of this Order is to restrict entry to the Affected Highways at all times, except for owners or occupiers of property adjoining or adjacent to the Affected Highways needing access to the property; or to the Police, NHS or Fire and Rescue service when exercising their statutory powers or duties; or employees or contractors of statutory undertakers in relation to gas, electricity, water or telecommunications provider requiring access to their apparatus situated on the Affected Highway; or Council staff and authorised contractors, when exercising their statutory powers or duties.

6. This Order authorises the installation, operation and maintenance of barriers on the Affected Highways. The location of the barrier is marked on the map attached at appendix 1 and described in Schedule 1.
7. Alternative route for pedestrians are identified by the thick black line on the map attached at appendix 1 and described in Schedule 1.
8. The Council will be responsible for the installation, maintenance and operation of the barriers. They can be contacted on 01782 234234.
9. This Order discharges the Public Space Protection Orders listed in Schedule 2 to this Order which will cease to have effect from XXXX.

The Council is satisfied on reasonable grounds that the conditions set out in Sections 59, 60, 61, 64 and 72 of the Act have been met and in all the circumstances it is necessary to make this Order for the purposes of preventing and or reducing crime and anti-social behaviour in and around the Affected Highways. The Council makes this Order because criminal and anti-social behaviour in and around the Affected Highways has had a detrimental effect on the quality of life of those in the locality. The effect or likely effect of this is of a persistent or continuing nature such as to make this unreasonable and justifies the restrictions imposed by this Order.

A person who fails without reasonable excuse to comply with a restriction imposed by this Order will be guilty of an offence and shall be liable on summary conviction to a fine not exceeding level 2 on the standard scale or a fixed penalty notice of a maximum of XXXX.

If any interested person wishes to question the validity of this Order on the grounds that the Council had no power to make it or that any requirement of the Act has not been complied with, he or she may apply to the High Court within six weeks from the date on which this Order is made.

Location Number: 1

Fishpond Way to Leek Road

Except as provided in Article 2 of this order no person shall use the public right of way over the highway at the side of 31 and 33 Fishpond Way and the side of 1501 and 1509 Leek Road, Abbey Hulton (“the highway”) at any time. The highway is shown between points A and B on the plan annexed to this order.

The restriction in Article 1 shall not apply to any person who lives in premises adjoin the highway or to any Police, Ambulance or Fire Service personnel acting in pursuance of statutory powers or duties or to any statutory undertake, gas, electricity, water or communications provider requiring access to their apparatus situated in the highway.

Barriers may be installed, operated and maintained at points A and B shown on the plan annexed to this order and at each end of the highway. The Council will be responsible for maintaining and operating gates. They can be contacted on 01782 234234

Except as provided in Article 2 of this Order no person shall use the public right of way over the highway to the side of 87 and 89 Mount Street, Northwood to the side of 56 and 58 Turner Street, Northwood the rear of 99 to 119 Mount Street, the side of 72 and 76 Mount Street, the side of 67a abd 69 old Street Northwood. The side of 40 and 56 Bold Street, the side of 57 and 59 Rose Street, Northwood and the rear of 32 to 74 Bold Street (inclusive), ("the highway") at all times. The Highway is shown between points A and B, C, and D, E and F on the plan annexed to this order.

The restriction in Article 1 shall not apply to any person who lives in premises adjoin the highway or to any Police, Ambulance or Fire Service personnel acting in pursuance of statutory powers or duties or to any statutory undertake, gas, electricity, water or communications provider requiring access to their apparatus situated in the highway.

Barriers may be installed. Operated and maintained at points A, B and C and D, E and F and G shown on the Plan annexed to this Order and at each end of the highway.

The highway is shown between points A and B on the plan annexed to this order.

The restriction in Article 1 shall not apply to any person who lives in premises adjoin the highway or to any Police, Ambulance or Fire Service personnel acting in pursuance of statutory powers or duties or to any statutory undertake, gas, electricity, water or communications provider requiring access to their apparatus situated in the highway.

Barriers may be installed, operated and maintained at points A and B shown on the plan annexed to this order and at each end of the highway. The Council will be responsible for maintaining and operating gates. They can be contacted on 01782 234234

Barriers may be installed, operated and maintained at points A, B, and C and at each end of the highway. The Council will be responsible for maintaining and operating gates. They can be contacted on 01782 234234

The alternative route for pedestrians which is available for use during the period the highway is restricted is via Conway Street, Leek Road or Boughey Road. This is indicated by a solid black line on the accompanying plan.
