Notification of Completion of Work:

- Building Control should be notified of completion of works 5 days prior to occupation and within 5 days of completion.
- Failure to give this notice is a criminal offence. The effect of not giving notice is that the legal
  options available to Building Control to enforce the Building Regulations reduce over a period of
  time.
- With this in mind, North Staffordshire Building Control Partnership will not normally undertake a
  completion inspection on work that has been completed or occupied for more than 12 months
  without considering the situation of each individual scheme.
- Were a building, extension or alterations to a property have been completed or occupied in excess of 12 months but less than 5 years, then a request for a completion inspection must be made in writing by completing the relevant application form.
- A charge is required and must be paid in advance of this inspection. Please see our Schedule of Charges for more information.
- A Building Regulation Completion Certificate will only be issued if the work is found to be compliant.
- It is important to remember that failure to notify Building Control on completion of work or occupation of a building could ultimately cause difficulties in selling a property.
